## Environmental Policy

Reeman Constructions is committed to reducing the impact of its operations on the environment. We acknowledge that as a service organisation we can minimise the negative impact of the following on construction projects:

- Land disturbance erosion, contaminated stormwater, de-watering site, dust control and management of stockpiles
- Noise and vibration operating hours, vehicles and equipment, traffic, noise abatement and vibration management
- Release of un-natural / hazardous materials to environment (land, water, natural or managed)
- Disposal and management of Hazardous Materials such as Asbestos, Led Paint, Silca and contaminated soils.
- Waste minimisation.
- Storage of chemicals and fuel.
- Road cleaning.
- Flora and Fauna localised in areas of construction.

We maintain and continuously improve a Management System that complies with the requirements of ISO 14001:2015 and all environmental legislation and other requirements which are relevant to Reeman Constructions.

Our environmental objectives are to:

- Minimise impact on the environment in all our activities, from procurement to the footprint left as result of construction.
- Actively engage in practices and employ processes to:
  - Prevention of pollution, to the environment (Flora, Fauna),

- Pursue environmental best practice and the prevention of pollution in office management and general construction operations
